HCC Dental Hygiene Clinic Protocol

- Bring current list of medications
- Patients are scheduled with students instructed by clinical dental hygiene faculty
- Do not anticipate full treatment to be completed in a single visit; the educational experience level of the student and a patient’s dental needs will determine the number of appointments required.
- Dental Hygiene Treatment consists of:
 - Medical history screening
 - Blood pressure screening
 - Head and neck cancer screening
 - Dental x-rays
 - Oral health education
 - Dental prophylaxis: scaling and polishing
 - Fluoride treatment
- A medical clearance from your personal physician may be needed
- Referrals will be given to patients who need dental and/or dental hygiene services beyond the scope of practice in the HCC Dental Hygiene Clinic
- HCC Dental Hygiene Clinic follows current regulations and recommendations as outlined by OSHA, CDC, ADA, and North Carolina State Board of Dental Examiners.

COVID-19 Policies & Procedures**

What we are doing:

- Staying informed.
- Providing care in the safest way possible.
- Following recommended infection control practices to prevent transmission, including screening all patients for COVID-19 signs and symptoms, universal source control, and infection control practices specific to COVID-19.
- Contacting all patients prior to dental hygiene treatment.
- Asking the patient to limit number of visitors accompanying the patient.
- Systematically assessing all patients and visitors upon arrival.
- Making sure all patients have face covering or offer facial masks.
- Asking about the presence of fever or other corona virus symptoms.
- Taking patient's temperature.
- Providing dental care ONLY if the patient is asymptomatic and their temperature is below 100.4 degrees Fahrenheit.
- Asking patient to re-don their face mask after services are rendered.
- Requesting that the patient inform the clinic if they develop any symptoms or are diagnosed with COVID-19 within 14 days following their visit.
- Taking steps to ensure that staff, students and patients adhere to guidelines.
- Setting up operatories so that only the clean/sterile supplies and instruments needed for the dental hygiene procedure are readily accessible.
- Avoiding aerosol-generating equipment such as ultrasonic scalers
- Placing patients at least 6 feet apart, physical barrier between chairs, and operatories.
- Wearing personal protective equipment and practicing proper hand hygiene
