The following are Program **Participant Contract Guidelines** for the Freedom to Learn Initiative (FLI). You will be responsible to the conditions specified on the by your assigned Learning Coach (LC). Failure to complete your contractual obligations may result in loss of FLI participant privileges and/or being dropped from the program.

1. Schedule and keep **four (4)** individual **counseling appointments** with your **Learning Coach (LC)**, each semester. Appointments cannot be made within the same week except in the case of an emergency.
2. Schedule individual **counseling appointments** with your **assigned Mentor, if needed**, each semester. Appointments cannot be made within the same week except in the case of an emergency.
3. Schedule and keep at least **one (1) counseling appointment** with a counselor from the **HCC counseling office, if referred by your LC**, each semester. To receive credit, you must have an FLI counseling verification card signed by the counselor.
4. Sign up for (**academic enrichment**) **tutoring** with your LC for **English or Math** if you receive a grade of **"C" or below**. You should participate in tutoring opportunities when you need help in other subject areas. Regular attendance at scheduled tutorial sessions is mandatory.
5. Sign up and participate in a minimum of **three (3) cultural/professional development workshops** each semester. Attendance requires you remain for the duration of the workshop. To receive credit, you **should complete** the respective **FLI workshop evaluation** provided at the end of the session. Evaluations should be submitted to your LC within 48 hrs.
6. Participant **should inform their assigned LC** anytime they will not be able to participate in an activity, workshop, or cultural event. Activities include but are not limited to the following:

Job fair (Fall semester) - <b>Mandatory</b>	College Tours (College Transfer Students)
Men to Men Summit (Spring semester) - <b>Mandatory</b>	Business and Industry Field Trips
Monthly Male Forum - <b>Mandatory</b>	Financial Aid Workshops
College Fairs (College Transfer Students)	Transfer Workshops (College Transfer Students)
FLI Student Orientation (New Participants) - <b>Mandatory</b>	Internships/Workshops (Limited Opportunities)

7. To stay abreast of all FLI activities and reminders, you are encouraged to regularly check your assigned HCC g-mail account and the FLI web page.

As a participant in the Freedom to Learn Initiative (FLI), I understand the contractual requirements for my participation and promise to fulfill the requirements of the above written Participant Contract agreement. I understand that failure to fully participate in the minimum required activities may be ground for dismissal from the program.
